Conditions

The following conditions are imposed in respect of the regulated activities undertaken.

1. The licenceholder's regulated activities are restricted to the following:
 - Class 2 – investment business – sub-classes (3) and (7).
2. The licenceholder is not permitted to hold client money or client assets.
3. As a licenceholder incorporated under the Companies Act 2006 the licenceholder shall, at all times:
 - i. maintain in force elections under Section 203 (filing of the register of members) and Section 204 (filing of the register of directors) of the Companies Act 2006 ("the Act") and shall comply with the requirements of the Act in respect of such elections; and
 - ii. maintain up to date copies of the minutes of its Board meetings and members' meetings either at the licenceholder's business premises on the Isle of Man or at the office of its Registered Agent.

NOTICE OF CONDITIONS IMPOSED BY THE ISLE OF MAN FINANCIAL SERVICES AUTHORITY ON LMS PARTNERS LIMITED ("THE COMPANY")

Using the powers available to the Isle of Man Financial Services Authority ("the Authority") under Section 25(5)(a) of the Insurance Act 2008 ("the Act") the Authority imposes the following conditions on the Company's ongoing registration as a General Insurance Intermediary under Section 25 of the Act:

Conditions

The Company is only permitted to intermediate on the following types of pure protection products:

- Life Cover
- Critical Illness Cover
- Income Protection Cover
- Group Schemes

As an insurance intermediary incorporated under the Companies Act 2006, the registered person shall at all times:

- i. notify the Authority without delay as soon as it becomes aware of any intention of its registered agent to resign as its registered agent under section 76 (resignation of registered agent) or section 77 (registered agent ceasing to be eligible to act) of the Companies Act 2006, or of its intention to change its registered agent under section 74 (change of registered office or registered agent).
