RETIREMENT BENEFITS SCHEMES ACT 2000

THE RETIREMENT BENEFITS SCHEMES ACT 2000 (APPOINTED DAY) (No. 2) ORDER 2001

In exercise of the powers conferred on the Treasury by section 56 of the Retirement Benefits Schemes Act 2000¹, and of all other enabling powers, the following Order is hereby made:—

Citation and interpretation

- 1. (1) This Order may be cited as the Retirement Benefits Schemes Act 2000 (Appointed Day) (No. 2) Order 2001.
- (2) In this Order -
 - (a) references to "the Act" are references to the Retirement Benefits Schemes Act 2000 and references to sections are references to sections of the Act;
 - (b) references to "international schemes" are references to 'international retirement benefits schemes' as defined in the Retirement Benefits Schemes (International Schemes) Regulations 2001².

Appointed day

- 2. (1) The provisions specified in Part I of the Schedule shall come into operation on
 - (a) in respect of international schemes which immediately before 1st January 2002 are operating in or from the Island, 1st June 2002;
 - (b) in respect of all other international schemes, 1st January 2002.
- (2) The provisions specified in Part II of the Schedule shall come into operation on 1st January 2002.

EXPLANATORY NOTE

(This note is not part of the Order)

This Order provides for the coming into operation, both wholly and partly, of certain provisions of the Retirement Benefits Schemes Act 2000 (c.14) from the days appointed in the Order.

Article 1 provides for the citation and interpretation.

Article 2(1) establishes the appointed day for the coming into operation, in respect of international schemes only, of those sections of the Act set out in Part I of the Schedule. For international schemes established and operating in or from the Isle of Man immediately before the 1st January 2002, the appointed day is the 1st June 2002. For all other international schemes, the appointed day is the 1st January 2002.

Article 2(2) establishes that the appointed day for the coming into operation, for all schemes, of those sections of the Act set out in Part II of the Schedule is the 1st January 2002.

NOTE AS TO EARLIER APPOINTED DAY ORDERS

(This note is not part of the Order)

The Retirement Benefits Schemes (Appointed Day)(No. 1) Order 2001 (S.D. 173/01) brought into force all of the provisions of the Act to the extent necessary for the purpose of making public documents under the Act.
