  - (ii) be filed and served no later than close of business on Monday, 26<sup>th</sup>

  - 2. Paragraph 6 be varied to allow response Affidavits from the Joint Petitioners and the other parties to be filed and served no later than Noon on Wednesday the 28<sup>th</sup> day of January 2009
