Global Financial Innovation Network ('GFiN') – One Year On

Fees from 1 April 2019

Following the **Consultation on Fees 2019**, the 2019 Fees under the Collective Investment Schemes Act 2008, Designated Businesses (Registration and Oversight) Act 2015, Financial Services Act 2008, Insurance Act 2008 and Retirement Benefits Schemes Act 2000 commenced on 1 April 2019.

UPDATES FROM OUR REGULATED SECTORS

BANKING

Quarterly Banking Statistics – 31 Dec 18

Deposit base figures and **quarterly banking statistics** for the period to 31 December 2018 were published on 28 February and 25 March 2019, respectively.

Quarterly Banking Statistics – 31 Mar 19

Deposit base figures and **quarterly banking statistics** for the period to 31 March 2019 were published on 30 May and 4 July 2019, respectively.

FUNDS AND INVESTMENT SERVICES

Quarterly Fund Statistics – 31 Dec 18

INSURANCE

Group Supervision Regulations 2019 and Corporate Governance Code of Practice for Designated Insurers

On 7 May 2019, the Authority issued a **Consultation Response** (CR19-04/T13) to its **Consultation Paper** (CP18-07/T13) in respect of the draft Insurance (Group Supervision) Regulations 2019 and the draft Corporate Governance Code of Practice for Designated Insurers. The Regulations and Code of Practice came into effect on 1 July 2019 which, together with primary legislative provisions already in force, brought into effect the group supervision framework for long-term business.

The Regulations and Code only apply to insurers where the Authority is Group Supervisor (of which there is a limited number). Requirements are introduced at group level in the areas of solvency, fitness and propriety, conduct of business, governance and reporting.

Insurance Business Roadmap – Jan 2019

On 31 January 2019, the Authority issued its updated Roadmap for the regulatory framework for insurance business. A copy of the Press Release and Roadmap can be found **here**.

Changes to the Capital Framework for Non-Life Insurers and Class 12 Proposals

On 22 July 2019, the Authority issued Consultation Papers on proposed regulations for an updated risk-based capital framework for nonlife insurers (CP19-05/T04) and on proposals to amend the criteria by which an insurer might qualify for a reduced or simplified level of regulation under a Class 12 authorisation (CP19-04/T04). Feedback on the consultations is requested by 13 September 2019.

UPDATES ON AML/CFT

GENERAL AML/CFT UPDATES

Guidance on Sanctions Screening

The Authority announced on 7 March 2019 that its AML/CFT Handbook will be updated to take account of the **recent publication** of guidance on sanctions screening by the Wolfsberg Group.

Updates to the AML/CFT Handbook

On 3 May 2019, the Authority published amendments to the AML/CFT Handbook. Details of the changes can be found in the **Press Release**.

Changes to AML/CFT Legislation

On 13 February 2019, the Authority and Department of Home Affairs issued a **Consultation Paper** (CP19-01/T19) on proposed changes to the Island's AML/CFT Framework. A **Consultation Response** was issued on 15 May 2019. Further information can be found in the **First** and **Second** Press Releases.

In tandem with the above, the Authority issued a **Consultation Paper** (CP19-02/T19) on the AML/CFT (Specified Non-Profit Organisations ('SNPO')) Code 2019. A **Consultation Response** was issued

on 15 May 2019. Further detail can be found in the **First** and **Second** Press Releases.

The AML/CFT Code 2019 and the AML/CFT (SNPO) Code 2019 came into effect on 1 June 2019. Information on the changes can be found on the AML/CFT Legislation webpage. Guidance will follow in due course. Schedule 4 to the Proceeds of Crime Act 2008 ('POCA') has also been amended to improve its layout and flow, and some definitions have been amended. A copy of the amended Schedule 4 can be found here.

AML/CFT Statistical Returns

On 1 July 2019, the Authority issued a **Press Release** stating that the filing date for the AML statistical return for the year ended 31 December 2018 would be extended to 31 December 2019.

Civil Penalties Regulations 2019

On 4 July 2019, the Authority announced that the **AML/CFT (Civil Penalties) Regulations 2019** had been brought into force following a consultation earlier in 2019. Further information can be found in the **Press Release**.

DESIGNATED BUSINESSES

Updates to AML/CFT Framework

Schedule 4 to POCA (which sets out what is business in the regulated sector) was amended as part of recent updates to the AML/CFT framework. The layout and certain definitions were amended:

- External Accountant to include the provision of insolvency services;
- Payroll Agent expanded definition;
- Specified Non-Profit Organisations ('SNPO')

 in order to be defined as an SNPO an organisation must now remit £2,000 rather than 30% of annual income.

In addition, Schedule 1 to the Designated Businesses (Registration and Oversight) Act 2015 has been amended to reflect the changes made to Schedule 4 to POCA and include the designated business definitions in the body of the Schedule.
